WHEREAS, it is anticipated that additional costs, not fixed at this time, will be sought by Metromedia; and

WHEREAS, the original funds authorized by Council are almost depleted and it is necessary to supplement Resolution No. R-253182; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Auditor & Comptroller be and he is hereby authorized to transfer the sum of \$5,000 from the Unallocated Reserve (605) to Resolution No. R-253182 to supplement said resolution for the purpose of defraying expenses incurred in the case entitled Metromedia, Inc., et al. v. City of San Diego.
