Robert J. Daneri Henry T. Yarznbowicz	General Services	\$ 505	Mr. Daneri is an Equipment Repair Supervisor and Mr. Yarznbowicz is a Fabrication Repair Supervisor in the Equipment Division. One year ago they earned a partial award of \$480 for their suggestion to add two inches of material to one side of the cutting edges of the landfill dozers when they are rebuilt. One year's experience has shown a savings of \$3,285. This is the remainder of their award.
