Myrna F. Choate	Risk Management	\$ 200	Ms. Choate is an Administrative Aide II. She suggested that the City's safety eyeglass program be operated through an outside agency. The actual first year's savings from this suggestion are \$1,978 in labor costs.
Francisco Diaz	Water Utilities	\$ 185	Mr. Diaz is an Equipment Technician II in the Systems Division. He suggested that the rock filter system for the aquaculture research project be constructed with p.v.c. pipe and nylon bags. This is expected to save \$609 in the first year in labor and material costs.
Caroline McCullagh	Building Inspection	\$ 165	Ms. McCullagh is a Building Technician II. One year ago she earned a partial award of \$230 for her suggestion to make several revisions to the Building Permit Application form to simplify processing. One year's experience has shown a savings of \$1,316. This is the remainder of her award.
Mary E. Walker	Personnel	\$ 160	Ms. Walker is a Senior Clerk. One year ago she earned a partial award of \$65 for her suggestion to discontinue filing the Safety Training Certificates in the Personnel Department employee jacket. One year's experience has shown a savings of \$746. This is the remainder of her award.
James K. McCormick	General Services	\$ 155	Mr. McCormick is a Building Manager in the Buildings Division. One year ago he earned a partial award of \$170 for his suggestion to specify the office location as the delivery site for Police equipment purchases. One year's experience has shown a savings of \$3,271. This is the remainder of his award.
