WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

Joseph Liera	Water Utilities	\$ 55	Mr. Liera is an Equipment Technician II in the Systems Division. He suggested that the sludge retaining wall for the aquaculture research project be constructed from concrete block. This is expected to save \$181 in the first year in labor and material costs.
Janet L. Eggleston	Property	\$ 25	Ms. Eggleston is an Administrative Aide at Mt. Hope Cemetery. She suggested that clients with grave reservations be notified by post card when the reservation expires. The suggestion has been implemented, and lot sales resulting from the notification system will be recorded. This is a partial award pending a final 12-month review.
Henrietta L. Barnett Ronald H. Ransom	Water Utilities	\$ 20	Ms. Barnett worked in Water Utilities and Mr. Ransom works in the Print Shop. One year ago they earned a partial award of \$215 for their suggestion to eliminate an unnecessary mail run. One year's experience has shown a savings of \$755. This is the remainder of their award.
Davis E. Darnell	General Services	\$ 20	Mr. Darnell is a Sanitation Supervisor in the Streets Division. One year ago he earned a partial award of \$30 for his suggestion to attach a platform to the front of the weed spray trucks for operator safety. Although savings were difficult to estimate, this was considered to be a significant safety improvement and an additional award was approved.
Robert E. Crist	Fire	\$ 20	Mr. Crist is an Auto Messenger. He suggested that mop buckets and wringers be issued under separate stock numbers. Although savings were difficult to identify, this was considered to be a significant operational improvement. This is a partial award pending a final 12-month review.
