


RESOLUTION No. R- 255906 (R-82-1297)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of BIO-GAS OF COLORADO, INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of ONE (1) EACH ANAEROBIC DIGESTION SYSTEM WITH OPTIONAL EQUIPMENT (safety rail, equipment building, sample valves, sight gauge and chromatograph) for a total cost of \$117,466.00; terms net 30 days, plus sales tax.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$124,513.96 within the Sewer Revenue Fund (41506) from the Unallocated Reserve (70697) to the Wastewater Research Program (70217).
