
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager is hereby authorized to execute utility agreements with San Diego Gas & Electric Company and Pacific Telephone Company for the purpose of installing underground utilities in Carroll Canyon Centre Subdivision Assessment District, copies of said agreements are on file in the office of the City Clerk as Documents No. RR- 255919-1 and No. RR- 255919-2, respectively.

2. That the expenditure of \$17,898 from Special Fund No. 79280 for the purpose of providing advance payment to San Diego Gas & Electric Company for the installation of gas distribution facilities is hereby authorized.

3. That all rebates from said utility agreements be deposited in Fund No. 79281, the Reserve Fund, Carroll Canyon Centre Subdivision Assessment District.
