

RESOLUTION NUMBER R- 255923

Adopted on MAR 01 1982

WHEREAS, it is now necessary for the Council to elect from among the list of nominees two persons to fill the existing vacancies pursuant to the procedure set forth in Council Policy No. 000-13; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, acting on behalf of The City of San Diego, sole member of the San Diego Transit Corporation, as follows:

That JOYCE BEERS and CLARENCE M. PENDLETON, JR. are nominated for election to the Board of Directors of the San Diego Transit Corporation.

BE IT FURTHER RESOLVED, that after full and complete public discussion and deliberation, JOYCE BEERS and CLARENCE M. PENDLETON, JR. are hereby elected to the Board of Directors of the San Diego Transit Corporation for four year terms expiring on December 31, 1985.
