

RESOLUTION NUMBER R- 255926

Adopted on MAR 01 1982

WHEREAS, Section 8330 et seq. of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where that portion of a street to be vacated is excess right-of-way not required for street or highway purposes; and

WHEREAS, a portion of Conifer Avenue has been deemed excess right-of-way to City needs and is not required for street or highway purposes; and

WHEREAS, those properties adjoining that portion of Conifer Avenue to be vacated will continue to have access or will be accessible by the nature of the lots created with the approval on this date of the subdivision to be known as Palm Avenue Shopping Center; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That a portion of Conifer Avenue, as more particularly shown on Drawing No. 15557-B on file in the office of the City Clerk as Document No. RR- 255926, which is by this reference incorporated herein and made a part hereof, be, and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.

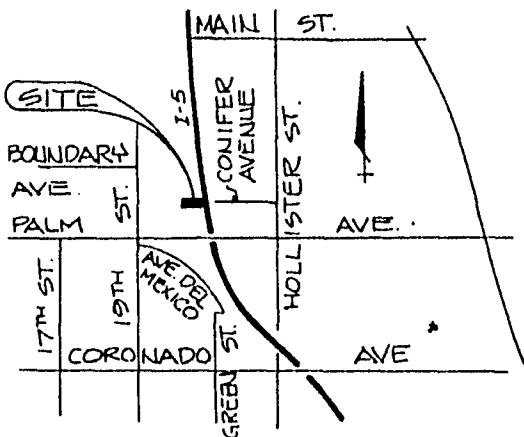
THE CENTERLINE OF 19TH STREET PER MS 742, IE N 1° 08' 11" E

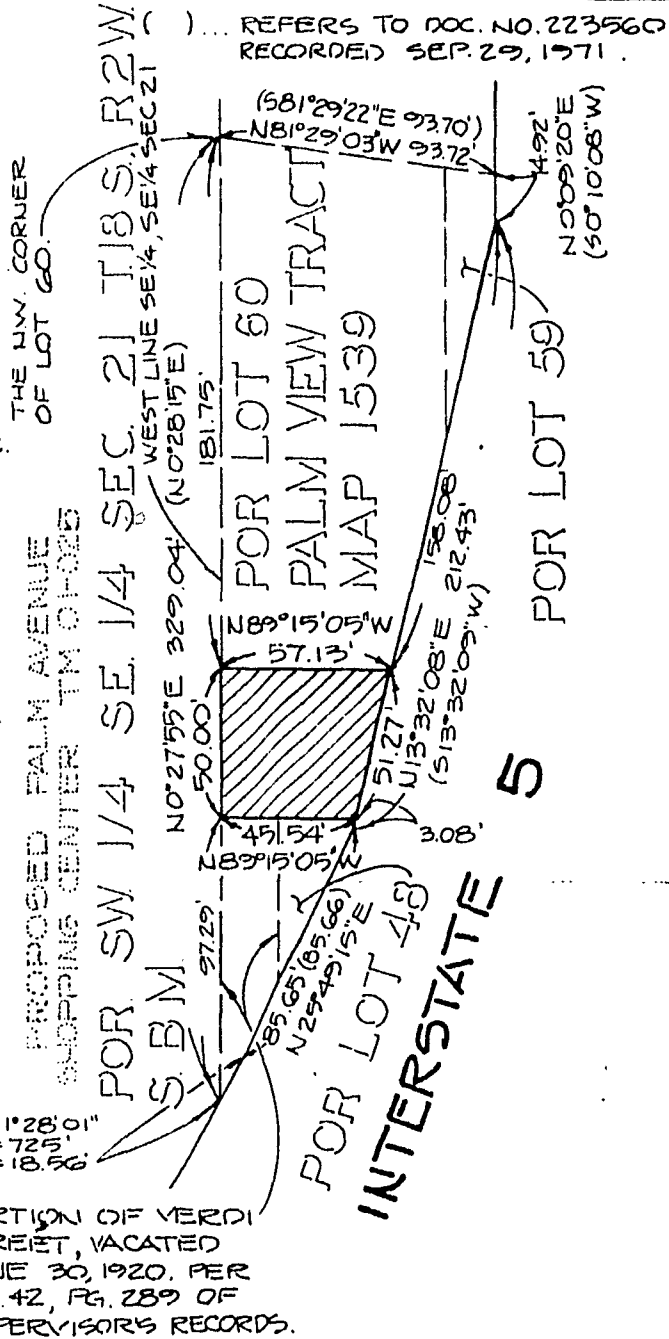
