That Change Order No. 5, dated January 8, 1982, heretofore filed with the City Clerk of said City as Document No. AR-255948, issued in connection with the contract between The City of San Diego and Granite Construction Company for construction of the West Point Loma Interceptor Sewer (Point Loma Wastewater Treatment Facilities Accelerated Projects Construction Contract C-6), said contract having been filed in the office of the City Clerk as Document No. A-00131, be and the same is hereby approved; and the changes therein set forth, amounting to a net increase in the contract price of \$88,500, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of a sum not to exceed \$88,500 is hereby authorized from Sewer Revenue Fund 41506 for the sole and exclusive purpose of providing funds for the above project.
