

RESOLUTION NUMBER R- 255852

Adopted on MAR 8 1982

WHEREAS, City of San Diego Planetarium Revenue Bond No. 204, 5.60%, due November 1, 1985, \$5,000 par value, with no coupons attached and registered under the name of R. W. Cole, 62915 Spring Creek Road, Montrose, Colorado, 81401, cannot be found or produced; and

WHEREAS, a request has been received to pay \$5,000 at maturity in lieu of the lost bond; and

WHEREAS, a Lost Security Bond in the amount of \$12,500 has been received to indemnify the City for possible loss due to making such payment; and


WHEREAS, this request complies with the provisions of Section 53460 and following sections of the Government Code which establish a procedure under which the owner of a lost bond or coupon may be paid for the amount of his loss; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the pay-in-lieu of the issuance of a new bond to R. W. Cole, the registered owner, to replace Bond No. 204, San Diego Planetarium Revenue Bond, 5.60%, due November 1, 1985, which has been lost mislaid, destroyed or stolen, be and it is hereby authorized.
