WHEREAS, City of San Diego 1981 Tax Anticipation Notes Nos. 93 and 94, 10.00%, due June 28, 1982, totaling \$200,000, cannot be found or produced, and a request has been received to issue new or duplicate notes to Smith Barney, Harris Upham & Co., the owner, or to pay them for the notes; and

WHEREAS, a lost instrument affidavit and an Indemnity Bond for double the value have been received to indemnify the City for possible loss due to the reissue or making such payment; and


WHEREAS, this request complies with the provisions of Section 53460 and following sections of the Government Code which establish a procedure under which the owner of a lost security or coupon may be paid for the amount of the loss; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the reissuance of two City of San Diego 1981 Tax Anticipation Notes to Smith Barney, Harris Upham & Co. to replace Notes No. 93 and No. 94, 10.00%, due June 28, 1982, totaling \$200,000, which have been lost, mislaid, destroyed or stolen, be and it is hereby authorized.
