WHEREAS, the Memorandum of Understanding, now in effect, between the City of San Diego and the San Diego Police Officers' Association provides that "grievances arising out of the disagreement on interpretation or application" of the Memorandum shall be resolved by the City Council absent a prior resolution; and

WHEREAS, the San Diego Police Officers' Association grieved an order by the Police Chief issued on April 27, 1981, commanding all personnel to reduce their "compensatory time" balance to sixteen (16) hours by June 30, 1981; and

WHEREAS, there was not a prior resolution of the grievance; and

WHEREAS, the City Council conducted a hearing and the matter was submitted to them by the parties for a decision; NOW, THEREFORE,

BE IT RESOLVED, that the City Council finds that the order of Chief of Police issued on April 27, 1981 is not compatible with the rights secured by the San Diego Police Officers' Association in their current Memorandum of Understanding and does therefore resolve the grievance in favor of the Police Officers' Association.

BE IT FURTHER RESOLVED, that the City Council directs the Management Team and Police Officers' Association to meet in an

attempt to arrive at a joint recommendation of an appropriate remedy. Absent such a joint recommendation, the City Council shall determine an appropriate remedy.
