RESOLUTION NUMBER R- 255964


Adopted on MAR 9 1982

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of the City of San Diego, a three (3) year Nonexclusive Use Permit with KELCO, a division of Merck and Company, Inc., for use of 400 acres of unimproved vacant land for agricultural purposes at Brown Field Airport, at an annual rental of \$6,000, with the additional consideration of mowing and weed control on the premises and other specified airport areas, performed in a manner satisfactory to the City Manager, under the terms and conditions set forth in that Nonexclusive Use Permit on file in the office of the City Clerk as Document No. RR- 255964.
