

RESOLUTION NUMBER R- 255866

Adopted on MAR 9 1992

WHEREAS, the Barrio Logan/Harbor 101 Community area is a mixed-use area with industrial activities existing adjacent to residences; and

WHEREAS, such differing uses often create problems for area residents and businesses and numerous requests are received from the community by City staff to help alleviate such problems; and

WHEREAS, it is important that the various City departments work together to efficiently resolve when feasible such problems; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the City Manager is hereby authorized and directed to form a committee composed of representatives from the various City departments to be called the Barrio Logan Improvement Task Force.


BE IT FURTHER RESOLVED, that the purpose of said task force shall be the coordination of staff review and response to requests for assistance to resolve problems arising within the Barrio Logan/Harbor 101 Community area.

BE IT FURTHER RESOLVED, that said task force shall operate informally and shall make recommendations to the City Manager and appropriate department heads so that decisions and actions can efficiently be made.

BE IT FURTHER RESOLVED, that all actions by the committee and its members shall be in accordance with the authority vested in the City Manager and the department heads and all committee operations shall be subject to approved budgeted resources.
