1. Balboa Park Fire Alarm Headquarters - Renovation (\$196,602);
2. Los Penasquitos Canyon Preserve - Master Plan and Initial Development (\$100,000); and
3. Talmadge Canyon Acquisition (\$100,000)


from; and add
