

That the bid of \$27,449.28 by HARTCORE INC., dba CRETE PLANER CO., a corporation for SAN DIEGO JACK MURPHY STADIUM PLAZA LEVEL PAVING IMPROVEMENTS, Bid Schedule D in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the Purchasing Agent.
