BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the State of California for the installation of a traffic signal and safety lighting system at the intersection of the Route I-805 northbound off-ramp and the eastbound lanes to Clairemont Mesa Boulevard, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 255992.

BE IT FURTHER RESOLVED, that the transfer of \$46,425 from Capital Outlay Fund 30245, CIP 61-001, signal installations to accommodate sudden changes in traffic patterns/volume to CIP 68-001 Cooperative Projects is hereby authorized.

BE IT FURTHER RESOLVED, that the expenditure in the sum of \$75,800 from Capital Outlay Fund CIP-68-001, is hereby authorized, solely and exclusively for the purpose of providing funds for the above program.
