RESOLUTION NUMBER R- **255993**

Adopted on MAR 15 1982

WHEREAS, on June 18, 1979 the City Council adopted Resolution No. 223741 authorizing the City Manager to apply for and execute a grant agreement with the CALTRANS Division of Aeronautics to resurface the Montgomery Field runways, taxiways and transient aircraft parking ramp, and further authorized the expenditure of \$12,500 from Airport funds for the project; and

WHEREAS, CALTRANS has notified the City that the project has been selected for inclusion in the 1981 State Transportation Improvement Program for Fiscal Year 1981/82 and has requested resubmittal of the application, NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the City Manager be and he is hereby authorized and empowered to apply for and execute, for and on behalf of said City, a grant agreement with CALTRANS Division of Aeronautics to resurface the Montgomery Field runways, taxiways and transient aircraft parking ramps. Said application is on file in the office of the City Clerk as Document No. RR- **255993**



Article 2 of CALTRANS Division of Aeronautics, Guide to the California Aid to Airports Program.

BE IT FURTHER RESOLVED, that the addition of CIP 31-139, Montgomery Field Slurry Seal Project to the Fiscal Year 1982 Capital Improvements Program, and the transfer of \$195,000 from Montgomery and Brown Airports Annual Allocation CIP 31-001, Capital Outlay Fund 30245 to CIP 31-139, Montgomery Field Slurry Seal, are hereby authorized.
