RESOLUTION OF THE COUNCIL OF THE CITY OF SAN
DIEGO, CALIFORNIA, AUTHORIZING AGREEMENT FOR
THE NEGOTIATED SALE AND PURCHASE OF IMPROVE-
MENT BONDS.

(Assessment District No. 3969 - Rio Vista Center)

BE IT RESOLVED by the Council of the City of San Diego
as follows:


1. That the City Manager be and he is hereby
authorized and empowered to execute for and on behalf of the
City an agreement with STONE & YOUNGBERG for the negotiated
sale and purchase of improvement bonds for Assessment District
No. 3969 - Rio Vista Center, said agreement being on file in
the Office of the City Clerk as Document No. RR 256007.

Section 2. Said agreement shall not be effective
unless and until all of the following have occurred: (a) when
the Council orders the work substantially as proposed in these
proceedings; (b) when the Council confirms the assessment to
pay the cost and expense of said work as provided in these pro-
ceedings; (c) Ordinance No. 0-15668 (New Series) of the Council
becomes effective; and (d) the Council orders the issuance of
bonds pursuant to the provisions of Part 7 of Division 23 of

the San Diego Municipal Code as added by said Ordinance
No. O-15668 (New Series).
