Conditional Use Permit No. 408-PC Third Extension of Time

This Conditional Use Permit extension of time for a period of 18 months is granted by the City Council of The City of San Diego to WILLIAMSON ENTERPRISES, Owner, hereafter referred to as "Permittee," for the purposes and under the terms and conditions as set forth in Conditional Use Permit No. 408-PC, on file in the office of the County Recorder as Document No. 750821, with the following amendments recommended by the Engineering Department of The City of San Diego:

Amend Condition 15a to read:

a. Hollister Street is to be ultimately improved as a 64-foot-wide collector street within a 79-foot-wide right-of-way, with a five-foot curb-to-property line distance on the east side adjacent to the San Diego and Arizona Eastern Railroad right-of-way. In connection with this CUP, the Permittee shall dedicate 13 feet of right-of-way adjacent to the development, construct curb and five-foot-wide sidewalk with a 10-foot curb-to-property line distance, and provide paving sufficient to meet the existing paving in a manner satisfactory to the City Engineer. A suitable transition shall be provided at the southerly end of the improvements.

Amend Condition 15c to read:

c. The permittee shall grant a 25-foot-wide sewer easement east and west through the property, at a location

satisfactory to the City Engineer, for the future Otay Valley Trunk Sewer. No structures or trailer spaces are to be located on this easement.
