That the San Diego Housing Commission is hereby authorized to acquire the property at 5326 Rex Avenue, the property at 3617-19 42nd Street, the property 3420 43rd Street, and the property at 3335 Van Dyke for the construction of HUD-financed rental housing for low-income families.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to release \$351,900 from the Fifth Community Development Block Grant Entitlement Year, Fund 18515, Dept. 5905, Org. 5908 (Low-Income Housing Site Acquisition Project), for purchasing the following sites:

1. 5326 Rex Avenue \$ 81,300
2. 3617-19 42nd Street 85,300
3. 3420 43rd Street 185,300

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to release \$117,300 from the Sixth Community Development Block Grant Entitlement Year, Fund 18516, Dept.

5972, Org. 7202 (Low-Income Housing Site Acquisition Project),


