RESOLUTION OF INTENTION NO. R- 256037

Adopted on MAR 22 1982

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE PUBLIC STREETS, HIGHWAYS, AND SERVICE EASEMENTS VACATION LAW, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE AN OPEN SPACE EASEMENT IN LOT 1254 OF PENASQUITOS BLUFFS UNIT 10, AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

WHEREAS, the vacation of the City's interest in an unneeded open space easement affecting Lot 1254 of Penasquitos Bluffs Unit 10, as more particularly described in the legal description attached hereto as Exhibit "A", has been proposed by City staff since the City owns the affected property; and

WHEREAS, the City staff wishes to clear title to the land of said easement in order to permit better utilization of the property; and

WHEREAS, the public interest and convenience require the vacation of the open space easement in Lot 1254 of Penasquitos Bluffs Unit 10; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it is the intention of said Council to order the vacation of the open space easement in Lot 1254 of Penasquitos Bluffs Unit 10, as more particularly shown on Sheet 4, Map No. 8634, on file in the office of the City Clerk as Document No.

RR- 256037 .


The Council hereby elects to proceed, in making said vacation under the provisions of the "Public Streets, Highways, and Service Easements Vacation Law."

The Council hereby fixes 2:00 p.m. April 26, 1982,
in the Council Chambers on the twelfth floor of the City
Administration Building, Charles C. Dail Concourse, 202 "C"
Street, in said City of San Diego, as the time and place for
hearing all persons interested in or objecting to the proposed
vacation.

That The Daily Transcript, a daily newspaper published and
circulated and of general circulation, in said City of San
Diego, be, and it is hereby designated as the newspaper in which
the Street Superintendent of said City shall cause to be
published, in the manner and form required by law, notice of the
passage of this Resolution of Intention, and the Street
Superintendent is hereby directed to cause notices of the
passage of this resolution to be posted in the manner and form
required by law and to cause a notice similar in substance to be
published in said newspaper in the manner required by law.
