
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with LEIGHTON AND ASSOCIATES to provide professional engineering services in connection with the investigation of the Sonico Landslide.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the sum of \$47,000 within Sewer Revenue Fund 41506 from the Unallocated Reserve (70697) to Sewer Engineering Services (70641).

BE IT FURTHER RESOLVED, that the expenditure of a sum not to exceed \$47,000 is hereby authorized from Sewer Revenue Fund 41506 for the sole and exclusive purpose of providing funds for the above services.
