RESOLUTION OF INTENTION TO ACQUIRE OPEN SPACE  
LAND FOR THE SAN DIEGO OPEN SPACE PARK FACILITIES  
DISTRICT NO. 1

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The City Council, for and on behalf of the San Diego Open Space Park Facilities District No. 1, hereby declares its intention to hold a hearing to determine whether or not the District should acquire certain property owned by Lusk-Smith/Mira Mesa North, Pipefitters Welfare, John J. O'Mara, Trustee, The Cashin Company and The Fieldstone Company, and comprising approximately 153.53 acres in Lopez Canyon, which property is more particularly described as Assessors Parcels Nos. 311.020.11, 311.020.16, 311.020.02, 311.020.07, 311.020.09, 311.031.02, 311.020.08, 309.030.07, 311.031.03, 311.031.04, 309.030.08, 309.030.13, and 309.030.14, for open space park purposes.

2. That said parcels are more particularly described in that document on file in the office of the City Clerk as Document No. RR-256047.

3. That no park improvements to said property are presently proposed.

4. That on April 13, 1982, at the hour of 2:00 p.m. in the Council Chambers, City Administration Building, Charles C. Dail Concourse, 202 "C" Street, San Diego,


California, the City Council will hear any persons interested in the matter of the acquisition of said property and will consider and finally act on the acquisition of said property.

5. That the owner or owners of said property may appear at the hearing and be heard orally, or by writing signed by them, and present evidence for or against the acquisition of said property by the District.

6. That a copy of this resolution shall be posted on the bulletin board of the City Administration Building and be published in a newspaper of general circulation, printed and published in the City once a week for two weeks, the posting and first publication to be on or before the 10th day prior to the day of hearing.


