BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized to execute, for and on behalf of said City, an agreement with the COUNTY OF SAN DIEGO for the transfer of funds for the purpose of retaining Orrick, Herrington & Sutcliffe, a professional corporation, as legal/environmental consultant (\$60,000) and the Mitre Corporation as the technical/management consultant (\$40,000), under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-256056.

BE IT FURTHER RESOLVED, that the expenditure of \$100,000 is hereby authorized from the Unallocated Reserve as the City's share of the technical/management consultant for the SANDER Project, to review the standard offers for energy purchased under P.U.C. rules developed by San Diego Gas & Electric Co. (\$40,000); and to provide legal/environmental assistance in order to secure necessary environmental approvals and project permits (\$60,000).


