Joann E. Johnson	Library	\$ 185	Ms. Johnson is an Intermediate Typist. One year ago she earned a partial award of \$50 for her suggestion to store newspapers on racks rather than poles. One year's experience has shown a savings of \$2,355. This is the remainder of her award.
Lyman L. Tremble	Water Utilities	\$ 100	Mr. Tremble is a Principal Utility Supervisor in the Systems Division. One year ago he earned a partial award of a Certificate of Merit for his suggestion to apply urethane elastomeric to the exterior of digester domes. Although savings were difficult to identify, this was considered to be a significant operational improvement. This is the remainder of his award.
Blanche Solow	Police	\$ 85	Ms. Solow is an Intermediate Typist. One year ago she earned a partial award of \$85 for her suggestion to eliminate the printing, storing, filing and purging of the I.D. cards on all moving and parking citation books. One year's experience has shown a savings of \$560. This is the remainder of her award.
