David J. Rock	Park & Recreation	\$ 80	Mr. Rock is an Equipment Technician in the Central Division. One year ago he earned a partial award of \$25 for his suggestion to remove portapool channels prior to relocation. One year's experience has shown a savings of \$702. This is the remainder of his award.
Jacqueline S. Clayton	General Services	\$ 60	Ms. Clayton is an Auto Messenger in the Buildings Division. She suggested that pre-inked stamps be used in the mailroom for processing flats for mailing. This is expected to save \$192 in the first year in labor costs.
Susan C. Hamilton	Water Utilities	\$ 25	Ms. Hamilton is a Microbiologist III in the Metro Wastewater Division. She suggested that laboratory glass be recycled. Although savings were difficult to identify, this was considered to be a significant operational improvement.
