BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for

SILVERWING PARK IRRIGATION SYSTEM RECONSTRUCTION, San Diego, California

filed in the office of the City Clerk of the City of San Diego, California, on MAR 17 '82, and bearing official Document No. A-00297, be, and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Council has ascertained the current or prevailing rate of per diem wages paid by private employers in the City for each craft or type of workman or mechanic needed to execute the contract, and does hereby declare that the wage scale included in said specifications is the said current or prevailing rate for the various crafts therein mentioned.

BE IT FURTHER RESOLVED; that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for


SILVERWING PARK IRRIGATION SYSTEM RECONSTRUCTION.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to add CIP No. 29-433, Silverwing Park Irrigation System Reconstruction to the FY 1982 Capital Improvement Program.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$5,816.00 from PSD Fund 11721; \$4,839.00 from PSD Fund 11722; \$5,066.00 from PSD Fund 11723; \$4,877.00 from PSD Fund 11724; \$3,938.00 from PSD Fund 11725 and \$25,464.00 from PSD Fund 16725 to CIP 29-433, Silverwing Park Irrigation System Reconstruction.

BE IT FURTHER RESOLVED, that the expenditure of \$50,000.00 from CIP 29-433, Silverwing Park Irrigation System Reconstruction of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
