APPROVING MAP OF LUSK INDUSTRIAL PARK UNIT NO. 3

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by ROBERT G. SCHOETTNER, a Licensed Land Surveyor, entitled "LUSK INDUSTRIAL PARK UNIT NO. 3 Being a subdivision of a portion of Parcel 1 of Parcel Map No. 7870, in the City of San Diego, County of San Diego, State of California, according to Map thereof filed in the office of County Recorder of San Diego County, together with a portion of Mira Mesa Boulevard as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Scranton Road, Barnes Canyon Road and Lusk Boulevard for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedicated those portions of Lots 87 and 88 marked "Reserved for Future Street," as shown on this map, under the provisions of Section 66440 of the Government Code.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Mira Mesa Boulevard, adjacent and contiguous to Lot 87, all as shown on this map within this subdivision.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities and slopes, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map, and that said streets are accepted on behalf of the public as heretofore stated; that said Council has rejected those portions of Lots 87 and 88, marked "Reserved for Future Street," and those those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of sewer, water, drainage facilities and slopes, all as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego.
