

RESOLUTION NUMBER R- 256094

Adopted on MAR 29 1982

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those street and drainage easement deeds of PARDEE CONSTRUCTION COMPANY, a California corporation, bearing date of January 29, 1982; GARY M. LEEDS and MATTHEW C. STRAUSS, trustees of Fred S. Leeds and Bertha Leeds 1976 Trust under Declaration of Trust dated December 30, 1976, bearing date of February 16, 1982; and TITLE INSURANCE AND TRUST COMPANY, a California corporation, as Trustee under Trust 4R-8508-001, bearing date of February 3, 1982, all executed in favor of The City of San Diego, copies of which deeds are on file in the Office of the City Clerk as Documents No. RR- 256094 - 1 , RR- 256094 - 2 , RR- 256094 - 3 , RR- 256094 - 4 and RR- 256094 - 5 , granting to said City street and drainage easements in a portion of Lot 6 of Casa Mira View, Map 9257, and in a portion of the Southeast One Quarter of Section 30, Township 14 South, Range 2 West, S.B.M., as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street, and the same is hereby named CAPRICORN WAY.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
