WHEREAS, the City of San Diego leased 6,245 square feet of office space on the 3rd floor of the Centre City Building in September 1979 for the City Attorney's litigation division; and

WHEREAS, in the period since that lease was executed, eight additional staff (6 full time and 2 part time) were added to the litigation division; and

WHEREAS, additional office space is badly needed since the existing 3rd floor space is being used beyond its normal capacity; and

WHEREAS, additional space has become available on the 4th floor of said Centre City Building of which 1,275 square feet are deemed sufficient to accommodate staff requirements; and

WHEREAS, the proposed lease of said 1,275 square feet has been offered, turn key, at a base rental of \$.85 per square foot per month or an effective monthly rental of approximately \$1.09 per square foot when all renovation and additions are calculated in and amortized; and

WHEREAS, the proposed lease is so drawn as to coincide with the term of the existing 3rd floor lease, i.e., through August 31, 1984; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the City Manager be and he is hereby fully authorized to

execute, for and on behalf of said City, a 29-month Lease Agreement with the LAMDEN FAMILY TRUST, CHARLES W. & GERTRUDE LAMDEM, Trustees for the Centre City Building at 233 "A" Street, San Diego, California 92101, for the purpose of leasing 1,275 square feet of office space on the 4th floor of said building, for a period of 29 months commencing April 1, 1982 and expiring August 31, 1984 at a rental of \$16,701 per annum for the first year of the agreement, pursuant to the terms and conditions of the Office Building Lease on file in the Office of the City Clerk as Document No. Re-256100.
