1. That the City Attorney is hereby directed to initiate court proceedings to validate the designation of the North University City Area of Benefit for the purpose of levying and collecting facilities benefit assessments and the approval of a financing plan and capital improvements program with respect to in the North University City area of benefit;

2. That the City Auditor is hereby directed to hold all monies received from the North University City Facilities Benefit Assessment in a trust fund until the disposition of said facilities benefit assessment validation proceedings;


3. That the City Manager is hereby authorized to amend the employment agreement with Stradling, Yocca, Carlson and Rauth for additional professional services as requested by the City Attorney, a copy of which is on file in the office of the City Clerk as Document No. RR- 256111 ;

4. That the City Auditor and Comptroller is hereby authorized to transfer \$20,000 from the unallocated reserve

solely and exculsively for purposes of said additional
professional services.
