RESOLUTION NUMBER R-256114

Adopted on March 29, 1982

WHEREAS, Lake Murray, located within the boundaries of Mission Trails Regional Park, is a valuable recreational asset for the citizens of San Diego and the region; and

WHEREAS, Lake Murray has been closed for recreational purposes since 1979 because of the presence of Hydrilla, a noxious water weed which by its thick growth can restrict water flow and make Lake Murray unusable; and

WHEREAS, the closing of Lake Murray has deprived the citizens of San Diego and the region of a valuable recreational resource; and

WHEREAS, The City of San Diego has, in cooperation with the County of San Diego and the State of California, undertaken a vigorous program to eradicate the Hydrilla weed; and

WHEREAS, the program to eradicate the Hydrilla may allow the opening of Lake Murray on a limited basis with appropriate controls; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the California Fish and Game Commission, which has jurisdiction to allow the opening of Lake Murray on a limited basis, be informed of the program to eradicate the Hydrilla and the possibility that conditions may allow the opening of the lake on a limited basis.

BE IT FURTHER RESOLVED, that City Councilman Dick Murphy appear before the Fish and Game Commission to discuss the Hydrilla eradication program and the potential for a possible limited opening.

BE IT FURTHER RESOLVED, that Councilman Murphy request that the Fish and Game Commission ask the appropriate State agencies to cooperate with The City of San Diego in doing the necessary studies to determine if Lake Murray can be safely opened on a limited basis.

BE IT FURTHER RESOLVED, that the results of such studies be submitted to the Council of The City of San Diego for a public hearing and full review of the information contained therein.

BE IT FURTHER RESOLVED, that the expenditure of \$12,500 is hereby authorized from Water Utilities Operating Fund (41500) for City's contribution to the State of California Department of Agriculture toward the cost of providing chemicals for the treatment of the Hydrilla in Lake Murray.
