That the acceptance by the City Manager of that street easement deed of MIDTOWN MINI-STORAGE LIMITED, a California limited partnership, executed in favor of The City of San Diego, bearing date of December 4, 1981, a copy of which deed is on file in the Office of the City Clerk as Document No.

RR- 256120, granting to said City the permanent easement and right of way for public street purposes over, under, upon, along and across a portion of Lot 9 of Block 19 of Marilou Park, Map No. 517, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named CEDAR STREET.

That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
