

RESOLUTION No. R- 256131 (R82-1565)



BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. NATIONAL EQUIPMENT RENTAL, 2. HORIZONS CONSTRUCTION, 3. SAN DIEGO EQUIPMENT RENTALS, INC., 4. C & M CRANE RENTAL INC., 5. DON'S BACKHOE RENTAL INC., 6. ANDERSON DRILLING CO., 7.
