


RESOLUTION No. R-256132 (R- 82-1564)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of CASE POWER & EQUIPMENT is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of ONE (1) EACH TRACTOR BULLDOZER WITH RIPPER at a cost of \$100,190.00; terms net 30 days, plus sales tax, with a trade-in allowance of \$20,000.00 for a Cat. D4PS Tractor 1977 model.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$86,201.40 within Sewer Revenue Fund (41506) from the Unallocated Reserve (70697) to Point Loma Treatment Plant Operation (70225).
