BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to Agreement with MEDEVAC, INC. (Document No. 764048), for provision of paramedic services, to remove the restriction against Medevac's providing nonparamedic emergency or nonemergency medical transportation services, under the terms and conditions set forth in the First Amendment to Agreement on file in the office of the City Clerk as Document No. RR-  
256159.

BE IT FURTHER RESOLVED, that the First Amendment to Agreement should provide that the consideration for the removal of the restriction against Medevac providing nonparamedic emergency or nonemergency medical is Medevac's agreement to continue to operate under the agreement as Medevac and the Manager negotiate until the City phases in a new program or one year from the date hereof, whichever is sooner.
