WHEREAS, in proceedings under the Municipal Improvement Act of 1913 (commencing with Section 10000 of the Streets and Highways Code) the Council adopted Resolution of Intention, Resolution No. R-255465, ordering the City Engineer to prepare the Report required by said Act and, pursuant thereto, the City Engineer has prepared the Report, including the parts submitted with and made a part of the Report, the parts consisting of plans and specifications describing the work and improvements, a diagram showing the assessment district and a proposed assessment of the costs and expenses of the proposed work and improvements, the Report being on file with the City Clerk; and

WHEREAS, the Council adopted Resolution No. R-255466, approving the Report, as filed, and appointing a time and place of hearing thereon; and

WHEREAS, based on the negotiated contract for the purchase of the bonds and the best bid for the construction of the work, the Council believes that the hereinafter described changes in the Report should be made prior to the conclusion of the hearing, and the City Engineer has prepared and submitted a




