BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of CONTROL TRAFFIC CORPORATION is hereby accepted; and the City Manager is hereby authorized to execute a contract for the purchase of TRAFFIC SIGNAL CONTROL EQUIPMENT per prices on file in the Purchasing Department; terms 1% 10 days, plus sales tax.

3. That the expenditure of \$1,361.76 from Capital Outlay Fund 30245, CIP 63-002, Replace Obsolete Traffic Signal Controllers, is hereby authorized to supplement funds previously authorized by Resolution No. R-254049, adopted on April 27, 1981.
