

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the acceptance by the City Manager of that street easement deed of PATRICK J. PARK and CAROL K. PARK, husband and wife; BARBARA A. TINNEY, an unmarried woman; and GOLDEN HILLS VILLAS, a limited partnership, executed in favor of The City of San Diego, bearing date of February 18, 1982, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 256185, granting to said City an easement for public street purposes over, along and across a portion of Lot 1 in Block 83 of Morse, Whaley and Dalton's Subdivision, Map 516, together with a portion of 34th Street as vacated to public use, all as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named BEECH STREET.

That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
