
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

EXHIBIT A

LEGAL DESCRIPTION

Road Dedication: Mercy Road

That portion of Los Penasquitos Canyon Preserve as described in File/ Page 80-055289, Book 1980, recorded February 19, 1980, in Rancho de los Penasquitos, according to the Map accompanying the Patent to said Rancho, recorded in Book 2, Page 385 of Patents, all in the Office of the County Recorder of the County of San Diego, State of California, more particularly described as follows:

Commencing at the Northwesterly end of a curve concave Southwesterly, having a radius of 1,000.00 feet and a central angle of $01^{\circ}59'06''$ as described in Document 79-186625, recorded May 7, 1979, in the Office of the County Recorder of said San Diego County; thence North $34^{\circ}14'00''$ West, 103.02 feet to the Southwesterly end of a line described in said Document 80-055289 as South $38^{\circ}10'00''$ West, 703.19 feet; thence North $38^{\circ}09'19''$ East (North $38^{\circ}10'00''$ East per said Document 80-055289), 51.41 feet to the TRUE POINT OF BEGINNING; thence North $34^{\circ}14'00''$ West, 26.72 feet to the cusp of a 26.00-foot radius curve, concave Northerly, a radial line to said cusp bears South $55^{\circ}46'00''$ West; thence South-easterly and Easterly along the arc of said curve through a central angle of $60^{\circ}13'41''$, a distance of 27.33 feet to a point on said line described in said Document 80-055289, a radial line to said point bears South $04^{\circ}27'41''$ East; thence South $38^{\circ}09'19''$ West (South $38^{\circ}10'00''$ West per said Document 80-055289), 13.73 feet returning to the TRUE POINT OF BEGINNING.

(Basis of bearings: Southeasterly portion of Rancho de los Penasquitos boundary line per R.O.S. 6204, i.e., $N45^{\circ}33'52''E$.)
