

That the acceptance by the City Manager of those street, sewer and drainage easement deeds of LPI CORPORATION, a California corporation, executed in favor of The City of San Diego, bearing date of February 4, 1982, copies of which deeds are on file in the Office of the City Clerk as Documents No. RR- 256189 - / and No. RR- 256189 - 2, granting to said City easements for street, sewer and drainage purposes in Lot 1 of International Industrial Park, Map No. 7249, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for public streets is hereby dedicated as and for public streets, and the same are hereby named CALLE PRIMERA, VIA SEGUNDO and VIA TERCERO.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
