BE IT FURTHER RESOLVED, that the expenditure in the sum of \$17,500 from the Sewer Revenue Fund (41506) Annual Allocation for Sewer Replacements (CIP 44-001) and Water Revenue Fund (41502) Annual Allocation for Water Main Replacements (73-083), is hereby authorized, solely and exclusively for the purpose of providing funds for the above program.
