WHEREAS, the Criminal Division of the City Attorney's office had submitted and had approved a request for expanded and remodeled office space on the 2nd floor, City Administration Building; and

WHEREAS, the remodeling entails revision of walls and floor space to better accommodate work flow and increase personnel and document security; and

WHEREAS, it was originally contemplated to do the work by outside contract but cost comparisons indicate that the cost is significantly lower by using City forces; and

WHEREAS, the Planning Department needs to remodel some of its space on the 4th and 5th floors as part of the "improved services" project relating to Planning and Zoning processing; and

WHEREAS, the Buildings Division of General Services department will fund the 4th and 5th floor remodeling since the costs were previously planned as part of the recarpeting project; and

WHEREAS, a transfer of funds in the amount of \$25,300 from the City Attorney's office to Buildings Division is required to accomplish the work on the 2nd floor since it was originally planned to be done by contract and Buildings Division did not allocate any funds for that project; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Auditor and Comptroller be and he is hereby authorized to transfer within the General Fund 100 the sum of \$25,300 from the City Attorney's Department (045) to the General Services Department, Buildings Division (5321) for the purpose of providing funds to remodel that portion of 2nd floor, City Administration Building, occupied by and planned for the Criminal Division of the City Attorney's office.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby further authorized to expend the sum of \$27,900 from authorized Buildings Division funds for the purpose of remodeling, as scheduled, certain portions of the 4th and 5th floors of the City Administration Building occupied by the Planning Department.

BE IT FURTHER RESOLVED, that by virtue of cost analysis and comparisons indicating a significantly lower cost by using City forces (See Attachment A), the City Manager is hereby fully authorized to use City forces in the above described remodeling of City Administration Building space on the 2nd, 4th and 5th floors.
