Pursuant to authority conferred by and in accordance with the provisions of Section 86.04 of the San Diego Municipal Code, a PARKING TIME LIMIT OF TWO HOURS, between the hours of 8:00 a.m. and 6:00 p.m., Saturdays, Sundays and certain holidays excepted be and the same is hereby established on the following street in said City:

LA JOLLA SHORES LANE to begin at the south property line at 9030 La Jolla Shores Lane and extend northerly on the west curb, around the perimeter of the cul-de-sac, then southerly to end at the south property line at 9090 La Jolla Shores Lane.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is hereby authorized to be made on said street, and the regulations hereinabove imposed shall become effective upon the installation of such signs.
