

RESOLUTION NUMBER R- 256206

Adopted on APR 12 1982

WHEREAS, revenue projections for state and local governmental purposes appear bleak; and

WHEREAS, in response thereto, legislation has been introduced to legalize lotteries with specific guidelines attached to the use of revenues derived; and

WHEREAS, the Director of the Intergovernmental Relations Department has reviewed the bills [AB 2414, ACA 65, (Kapiloff); AB 2363, ACA 62, (Hannigan); and AB 2577, (Vincencia)] and has reported thereon via report to the Rules Committee, dated March 8, 1982; and

WHEREAS, the Rules Committee considered the overview of State Lottery legislation and has acted upon the matter, approving the recommendations of the Intergovernmental Relations Department Director with the proviso that the primary position of the City is to eliminate all subventions and divert an additional one-cent sales tax from the existing six-cent sales tax levy for the exclusive use of the City; and

WHEREAS, in lieu of and secondary to the above expression of Council position, the City recommends that some assurance is memorialized by amendment to AB 2414 (ACA 65) so that the ability for local agencies to share in lottery revenues is assured; and

WHEREAS, review of the other proposed legislation reveals no impact or negative impact upon the City, warranting a neutral

position thereon; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that this Council, having reviewed the current legislation pending in respect to establishment of lotteries for the purpose of raising revenues, does hereby declare and express its position in respect thereto as follows:

1. That the City of San Diego proposes as its number one legislative recommendation, in lieu of the existing legislative proposals set forth herein, that all subventions be eliminated by establishing a single, identifiable source of revenue consisting of an additional one-cent of sales tax from the existing six-cent sales tax levy, to be appropriated for and used exclusively by local agencies.


2. Absent approval of the above, the City of San Diego supports AB 2414, ACA 65 (Kapiloff) provided it is amended to enable local government to equitably share with the school system in the lottery proceeds. Should this amendment be unacceptable, the City takes no position on this legislation.

3. AB 2363, ACA 62 (Hannigan) - The City takes no position on this legislation since it does not impact the City, fiscally or otherwise.

4. AB 2577 (Vincencia) - The City takes no position on this proposal because of the potential negative impact on the tourist industry.
