RESOLUTION NUMBER R- 256216

Adopted on APR 13 1982

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The City Manager is hereby directed to utilize the process for cost recovery that is set forth in Health and Safety Code Sections 25187 and 25187.5 (S.B. 618) which authorizes the State Department of Health Services to contract for services for hazardous material cleanup and emergency response.

2. The State Department of Health Services is hereby encouraged to formulate specific regulations for the utilization of the process set forth in Health and Safety Code Sections 25187 and 25187.5 (S.B. 618).

3. The County of San Diego is hereby supported in its effort to develop a hazardous material permit process to provide for additional inspection of hazardous material sites and emergency response capability.

4. The City Manager is hereby directed to notify the County of San Diego that commencing July 1, 1982, the City expects the County to assume the responsibility for hazardous material incidents since the County serves as the regulation and enforcement arm of the State in this area of concern and further that on a contract basis the City is willing to provide services which the County may require in the abatement of hazardous material incidents.

5. City staff is hereby directed to work with County staff to effect a smooth transition as the County assumes responsibility for emergency response activities.
