The City Council, acting for and on behalf of the San Diego Open Space Park Facilities District No. 1, having heard all protests against the acquisition of that property described in that Resolution of Intention No. R- 256047, adopted by the City Council on MAR 22 1982, 1982, hereby overrules such protests and determines that the public interest and convenience requires the acquisition of said property for open space park purposes.


BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to acquire said property.
