RESOLUTION NUMBER R- 256237

Adopted on APR 19 1982

WHEREAS, the City Council, by Resolution No. 208152 dated June 14, 1973, authorized the City Attorney or his designated representative to incur all necessary expenses in connection with participation on behalf of The City of San Diego in those certain hearings to be held before the California Public Utilities Commission and the Federal Power Commission in the matter of gas and electric rate increase applications by Pacific Lighting Service Corporation, Southern California Gas Company and San Diego Gas & Electric Company; and

WHEREAS, the Council authorized funds to be set aside from the Unallocated Reserve for the above purpose in order to defray continuing costs incurred in such participation; and

WHEREAS, the Council by Resolutions No. 213906 dated July 30, 1975; No. 216499 dated July 28, 1976; No. 219874 dated December 14, 1977; and No. 250509 dated October 29, 1979 authorized augmentation of said Resolution No. 208152 to provide funds for continued participation in such rate hearings; and


WHEREAS, said allocation and augmentation have been expended in support of PUC litigation and hearings and it is now desired and necessary to augment again said resolution to continue participation by San Diego in this field of concern;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of five thousand dollars (\$5,000) within Fund 100 from the Unallocated Reserve (605) to the Allocated Reserve (901) for the sole and exclusive purpose of providing funds to augment Resolution No. 208152 for expenses incurred in connection with said participation in the above California Public Utilities Commission and Federal Power Commission hearings relating to the San Diego Gas & Electric Company.
