Adopted on APR 20 1982

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager is hereby authorized to execute utility agreements with San Diego Gas & Electric Company and Pacific Telephone Company for the purpose of installing underground utilities in the Rio Vista Center Assessment District No. 3969, copies of said agreements are on file in the office of the City Clerk as Documents No. D2228-10 _____ and No. D2228-9, respectively.


2. That the expenditure of \$193,141.00 for the sole and exclusive purpose of providing advance payment to San Diego Gas & Electric Company for the installation of gas distribution facilities is hereby authorized from the bond proceeds.

3. That all rebates from said utility agreements be deposited in the Bond Reserve Fund for Rio Vista Center Subdivision Assessment District No. 3969.

4. That all of the authorizations contained in this resolution are contingent upon the actual sale of the bonds and the receipt of the bond proceeds by the City.
